The EPF Capacity Building Programme

EPF launched a Capacity Building Programme in 2012 with the overall objective of strengthening the capacity of both Member State and European level patient organisations to enable them to be more effective in achieving their objectives and aspirations and feeding their experiences and expertise into the work of EPF and utilising the outcomes of our collective work in a national, and/ or disease specific context. The project is co-financed by the Medtronic Foundation (2012) and unrestricted grants from the industry partners.

During the period 2012-2014 the Capacity Building Programme underwent its piloting phase. The outcomes of the piloting phase together with the findings of the evaluation conducted in each country involved and programme stage will be used to inform the design and delivery of the programme and its mainstreaming into the EPF annual plans from 2015 on. In 2015 the Capacity Building Programme will continue to be rolled out in the countries that joined the programme in 2012-2013, i.e. Romania, Hungary, Slovakia, and Bulgaria. A new country, most likely Poland, will join the programme in 2015. In the four countries that joined the Programme in 2012-2013 focus will be on delivering thematic training programmes on areas such as fundraising, advocacy, communications etc., while the new country(s) will focus on strategic and operational planning.
