General information

- Highest efficiency and best results for the patients can be achieved by the joint actions of healthcare professionals and patients' organizations
- Patients, patients' and professionals' organizations, all united around patients' health are only half of the equation. Before them stands the government and its regulatory bodies.

Collaboration between NGO's and the Bulgarian Medical Association - 2010

- 2010 the country trembles under the global economic crisis
 - Healthcare budget is shrinking
 - Hospitals fall in high debt
 - Grave financial distress in Bulgaria
 - Delay of payments to and from the hospitals

These lead to termination of scheduled patient reception

Collaboration between NGO's and the Bulgarian Medical Association - 2010

The preliminary healthcare budget for 2011 determined by the government is low

This threatens the function of the healthcare system in Bulgaria

Only urgent cases are received

This threatens patients' health and generates tension in patients and professionals.

Collaboration between NGO's and the Bulgarian Medical Association

Joint actions between patients' organizations, Bulgarian Medical Association, Bulgarian Dental Association, Bulgarian Association of Health Professionals in Nursing

A non-formal Public Council on Health Care is established

The Public Council declared willingness to strike across the country, which includes doctors, hospitals and pharmacies

They declare willingness to terminate work and strike

The emergency cases during the strike would be served

Collaboration between NGO's and the Bulgarian Medical Association

These give joint pressure on the government

The government undertakes precautions and starts negotiations with the Public Council

Meetings for discussion of the problems and the possible solutions are appointed

After a few meetings a consensus is established and the strike readiness is suspended

Results

The healthcare budget is enlarged.

Schedules for 2011 payments of hospital debts.

The National Health Insurance Fund's (NHIF) budget for 2011 is guaranteed.

In 2011 the healthcare system in Bulgaria functions successfully.

A little **budget surplus in NHIF** is expected b the end of the year.
