## Background

The Chain of Trust project (2011-2012) aimed at seeing whether and how views have evolved since the initial deployment of telehealth, and what barriers still exist to building confidence in and acceptance of this innovative type of service delivery among end-users.

The paramount goal of the project was to advance understanding of end-users perspective on telehealth services and enable patients and health professionals across the EU to benefit from the opportunities offered by telehealth. The project would ultimately contribute to the vision of high quality, patient-centred, equitable healthcare for all EU patients.

In order to achieve this goal two specific objectives have been defined:

- To improve available knowledge of the specific views, needs and perceptions of the added value and concerns among patients and health professionals with regard to telehealth services
- To increase awareness and understanding of users' perspective on telehealth among patients' and health professionals' organisations as well as health authorities at European and Member State level.

## Purpose and specific objectives of the conference

The purpose of the Chain of TRUST closing Conference is to increase awareness and understanding of users' perspective on telehealth amongst EU- and national-level stakeholders. Six specific objectives have been identified for this Conference:

- Share the main project findings and recommendations with the wide range of stakeholders
- Explore how project findings and recommendations can be used to foster telehealth policies and services
- Increase awareness of the role trust and acceptance play in fostering large scale uptake of telehealth services among their intended users
- Explore areas relating to user perspective on telehealth requiring further investigation
- Contribute to the sustainability of project results by defining strategies for taking forward project's findings and recommendations
- Foster better cooperation among different telehealth stakeholders to promote more user-centred telehealth policies and services.
