Background



- Equitable access to healthcare, for all patients across the EU at the heart of our vision and core values
- Good existing evidence base on the key socio- economic drivers and determinants of health
- Health inequalities have not however been studied much from the perspective of patients In some disease areas, EU wide data have been collected, but no accurate overview
- Inequalities persist in terms of access to healthcare and quality of care.

Our vision of access



- Availability + affordability of care
- our focus is on patient centred disease management as a part of the care continuum
- Specific needs of patients diagnosed with chronic conditions and their families



- Chronic diseases as a factor of health& social inequalities.
- Patient empowerment and health literacy as key components of the solution

Work with the EU institutions



- EPF contributed to the Consultation by the European Commission on EU action to reduce health inequalities
- Highlighted need for a strong political commitment at EU level
- Need to focus on chronic disease management and the needs of patients
- Need to improve data and knowledge base (patient centred indicators)
- European Parliament motion for resolution on health inequalities in the EU adopted in 2011
- We achieved recognition that patients are a specific group vulnerable to health inequalities
- Older patients where flagged as a priority

Health Technology Assessment



- May 2010 Seminar with patient experts on patient involvement in Health Technology Assessment (HTA)
- EPF survey with HTA agencies, patient organisations and decision makers on patient involvement
- EUnetHTA- EPF member of stakeholder forum
- EPF member of advisory board of AdoptHTA
- EUPATI project: Training for patient's representative and tools for lay patients on health technology assessment, pharmacoeconomics, pricing and reimbursement







EU Platform on access to medicines



- Dedicated to enhancing the collaboration among the Member States and relevant stakeholders
- To find common, non legislative approaches to timely and equitable access to medicines after their marketing authorisation.
- EPF was in the steering group and either us or our members were involved in various initiatives: access to biosimilars, entry agreement for innovative medicines, supply in small market, orphan products, WHO priority medicines...

EPF Campaign 2014: breaking down access barriers



"Access to quality healthcare is a basic EU citizens' right. Yet it is still not a reality for many of us — a situation made worse by the crisis."

"Access means the availability of treatment, and it affordability. Access also means non-discrimination".

"If we do not get the care we need at the right time, we may develop more severe illness, reducing our capacity to live a full and productive life and increasing health, social and economic costs. All of us deserve a chance to contribute to society"

EPF Campaign 2014: breaking down access barriers (2)



- Member States should be encourage to invest in health: health inequalities are unjustifiable and costly
- Shared concerns across health community – collaborating to find solutions
- Key ask: Support an EU initiative on equitable access to healthcare for all European citizens, through a multi-stakeholder platform
