GOAL:

To enable EPF to recognise, understand, meet and effectively represent the *needs and expectations of young patients* through their *meaningful involvement* and empowerment

EPF Youth strategy has four objectives:

- 1. Strengthening the involvement and representation of young patients in patient organisations
- 2. Promoting young patients' rights and recognition of their needs and expectations within and beyond health policy area
- 3. Promoting a better cooperation between young patient and adult patient advocates
- 4. Strengthening young patient representatives' skills and self-confidence



Rationale behind the Youth Startegy:

- Being a patient impacts on every aspect of a person's life
- Needs and expectations of young patients do not necessarily match those of adult patients
- Patient organisations need to listen to young patients and provide them with appropriate tools and avenues through which their needs and expectations can be put forward



- The Youth Strategy was adopted by the EPF 2011 AGM
- The Youth Group was set up in April 2011 and the recruitment is still on-going
- 1st Youth Meeting was held in Brussels in August 2011
- Representatives of the Youth Group attended the Conference on Rights and Needs of Old Patients (Warsaw July 2011) and the IV Regional Advocacy Seminar (Bucharest October 2011)
- A proposal for a first youth project was submitted under the EU Youth In Action Programme in February 2012 (awaiting results)





- EPF Youth Group is established as the **backbone** of the EPF Youth Strategy
- Currently made up of **11 young patient** representatives nominated by EPF members from eight European countries between 15 and 25 years of age
- The Youth Group is the reference group though which needs and expectations of the young patient community are formulated and communicated to EPF

EMPATHY Europe Meets Young Patients



To organise a four-day seminar for young patients, European policy-makers, and stakeholder actors in the fields of health, education, social and youth policy, in order to promote a more holistic approach to addressing young patients' needs in EU-level decision-making processes

How?

Through a mix of young patients and stakeholders-policy makers led activities:

- Policy role-play
- Policy discussions
- A day in a young patient's shoes
- Simulation of a press conference

EMPATHY Europe Meets Young Patients Resources to be delivered

- Recommendations for policy makers on how to take into account young patients needs
- Recommendations for stakeholder groups on how to take into account young patients needs
- Recommendations for patient organisations on how to involve young patients
- Toolkit for young patient advocates on ways to make their voice heard in EU policy making



Priorities of the

Youth Group for 2012

- Recruiting new members for the Youth Group (target 18 members by December 2012)
- Starting the EMPATHY project (pending outcomes of the application)
- Second Annual Meeting of the Youth Group in Malta, August 2012
- Developing a work plan for 2013
- Involving one member of the Youth Group in the EPF Policy Advisory Group
- Establishing relations with other youth organisations, and youth groups
- Defining a phasing out strategy for "older" members approaching the upper age limit (25 years).
