Welcome to the latest issue of our Newsletter! Brussels has been buzzing with many events and activities this October, and here are our highlights!

It is our pleasure to share with you that EPF will run a **public campaign** on the central issue of **Access to Healthcare** in the course of 2017! Focusing on the United Nations Sustainable Development Goal of **Universal Health Coverage for All by 2030**, our campaign will address the challenges faced by patients in terms of access to health and social care and propose avenues to break down these barriers. For more details, see our first article, here below. The **European Parliament own-initiative report on access to medicines**, drafted by MEP Soledad Cabezón-Ruiz (Spain, S&D) has been released! We have analysed the document carefully and have proposed a series of amendments.

Recent weeks have seen EPF represented in many external events. We report here on our participation in the **European Health Forum** that took place in Gastein late September, and you will read on our blog the report of **conference** organised by our Portuguese member on the **involvement of patients in policy shaping**.

The process of **Health Technology Assessment (HTA)** is a significant topic for patients and features as one of our work plan's priorities. In this issue, we share a general update on our recent patient -oriented HTA-related activities.

We also report on a major multi-stakeholder event organised by the European Commission on **biosimilar** medicinal products. As the final report is published, read our take on this important topic!

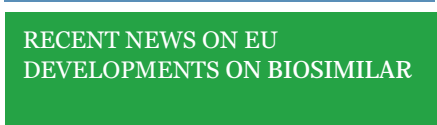
