EPF is seeking a Project and Capacity Building Officer who will be involved in the following tasks/activities:

- monitoring and implementation of various European projects in which EPF is currently participating, in particular EUPATI (Patients' Academy on Therapeutic Innovation)
- supporting the implementation of the EPF Capacity Building Programme for patients' organisations which is currently being rolled out in Romania, Hungary, Slovakia, Bulgaria, and Poland, as well as at the European level



Key Responsibilities:

- Operational responsibility for the implementation of the project activities,
- Representing EPF at project meetings as well as external events as needed
- Contribution to preparation of technical/progress reports related to EPF projects
- Writing dissemination materials and ensuring effective dissemination
- Planning, monitoring, and implementation of the EPF Capacity Building Programme for patient organisations at national and European level, which includes:
 - o design of new training modules
 - o identification and selection of local experts and trainers
 - liaising with EPF members and all other participating organisations in the countries concerned,
 - o supervising the work of external contractors to ensure they deliver on time, on budget and to the right standards of quality
 - o designing and implementing monitoring and evaluation plans and activities in respect of individual training modules as well as the Capacity Building Programme as such

- University degree in any related disciplines
- Minimum professional experience of three years in a similar capacity
- Knowledge of EU funding programmes, in particular the Public Health Programme, Horizon 2020 programme, and Innovative Medicines Initiative
- Experience in designing and delivering programmes, projects, and complex tasks on time and within budget
- Knowledge/experience in delivering capacity building programmes and activities, especially for NGOs
- Knowledge/experience of designing, implementing quantitative and qualitative research methods (surveys, focus groups, interviews, etc.) and reporting outcomes of such activities
- Experience of collaborative working between different stakeholder groups
- Experience in supervising the work of external consultant and trainers
- Fluent English, written and spoken and at least another European language
- High level ability to use electronic office tools (word processing, spreadsheets, email, Internet, etc.);
