Marco is Director for Digital, EU4Health and Health systems modernisation at the European Commission's Directorate General for Health and Food Safety (DG SANTE). Previously, he was Head of Unit for eHealth, Well-Being, Ageing and Deputy Director for Digital Society, Trust & Cybersecurity at the European Commission's Directorate General for Communications Networks, Content and Technology (DG CONNECT).

Notable initiatives that he had a leading role in include the EU COVID Certificate, contact tracing apps, and research and innovation endeavours related to digital innovations during the COVID-19 pandemic. Moreover, he supervised the 1 Million Genomes Initiative and the European Cancer Images Initiative. Prior to his current position, Marco has held various other roles within the European Commission, including Head of Unit for Learning, Multilingualism, Accessibility responsible for the Web Accessibility Directive, for digital language technologies, and Safer Internet for Children.



Pedro Carrascal

Pedro is the Executive Director of the Patient Organizations Platform (POP) since October 2022. POP is an umbrella of the main national patients organisations born 10 years ago to serve them in advocacy, awareness, patient based research and patient organisation empowerment.

He has a degree in Law and a Master's degree in business management and direction (MBA). He has been linked to the movement of people with multiple sclerosis since he was 8 years old and his mother was diagnosed with the disease, at which time she and others created the Multiple Sclerosis Association of Bizkaia. Plenary Session 3: Data Savvy Patients: Empowerment through AI Literacy in Healthcare



Moderated by Anca Toma

Anca joined EPF as Executive Director in March 2022. Her career started in the Romanian EU accession negotiations team, continued as a consultant in a public affairs and communications agency in Brussels, followed by ten years in Smoke Free Partnership, a European coalition of NGOs working to advance tobacco control for cancer and NCD prevention.

Her expertise lies at the intersection of digital health innovations, co-creation methods, AI ethics, and health policy. Ildikó has contributed to the development of the Dutch Integral Care Agreement and participates in various steering committees and advisory boards on privacy, ethics, and AI.

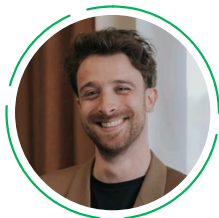
Keynote Presentation by Niklas Hedberg

Niklas is the Chief Pharmacist at the Swedish national governmental authority, the Dental and Pharmaceuticals Benefits Agency (TLV). Niklas is the Co-Chair of the HTAR Coordination Group with special expertise in pharmaceuticals. He was the Chair of the Consortium Executive Board for EUnetHTA21 (2021-2023) as well as the Chair of the EUnetHTA JA 3, Executive Board between 2018 and 2021.

Niklas has been working with pricing and reimbursement since 2001. He has held positions as medical assessor, project leader, Head of the Department for New Submissions (between 2009 and 2014) and he is now the Chief Pharmacist.

Niklas has a broad experience of different aspects of value based evaluation and over time has seen the increasing importance for health technology assessment (HTA) both across health care systems and on local level to prepare accurate decision making.
