Scenario 1: "perfect world"



- Structure of the Commission
 - Attention to healthcare \rightarrow separate DG
 - Strong political leadership in health (Vice-President)
 - Health in all policies
- European Parliament
 - Dedicated health committee
 - Many MEPs who are friendly to EPF, patient organisations, and civil society
 - EPF-friendly MEPs in leading positions with their (national or European) parties & in EP committees relevant to health

Scenario 1: "perfect world"



- Council
 - Support for more European action on health
 - Link to national elections and landscape at national level
- EMA
 - Increasing patient participation
- OECD and WHO
 - Closer and more strategic cooperation with EPF
- Opportunities affecting all
 - Availability of public funding for EPF
 - Role of CSOs: formalised involvement at EU level
 - Patient organisations recognised and included

Scenario 2: "health dystopia"



- Structure of the Commission
 - SANTE merges with non-health DGs
 - No Health Commissioner
 - "Health in all policies" without impact (everywhere & nowhere)
- European Parliament
 - No attention to health in Committees
 - No support to EPF from MEPs
 - Health-friendly MEPs in weak positions with their parties, weak links with leading positions in EP
- Council
 - No support for European action on health national retrenchment

Scenario 2: "health dystopia"




• EMA

- Following relocation, cuts to patient participation and involvement activities
- OECD and WHO
 - Exclusion of civil society, focus on Member States
- Opportunities affecting all
 - No public funding available for EPF
 - Role of CSOs
 - Focus on COIs exclusion of patient organisations
 - And/or no formalised involvement




