# EPF Constitution Change Proposal regarding holding online AGMs

EPF holds its biggest annual membership event, the AGM, every year around April. During this event important updates are shared with the representatives of all EPF Members, and essential votes are held – such as on the applications of new membership organisations being accepted into the EPF family, as well as changes of Board Members within the Governance Structure.

In 2020, EPF held its first ever online AGM, due to the COVID-19 pandemic. We are very grateful for the level of engagement and excitement that all our members showed during this event, ensuring its success despite the difficult circumstances.

However, since last April, legal rules within Belgium (EPF's country of registration) have changed. Currently it is not lawful to hold online AGMs with live voting unless the organisation's Constitution explicitly allows it. This EGM would allow you, the EPF Members, to vote on whether you agree with such a Constitutional amendment.

While we are not sure if 2021 would certainly require an online AGM yet, for the sake of the safety of our community, we would like to have that option. A positive EGM vote would allow this.

EPF invites all its members to share their experience and the impact of the COVID-19 pandemic on them as patients with chronic conditions, their communities and on patients' organisations.
