1. Health Services

As informed previously, the European Commission is currently working on a proposal on health services to be adopted by the end of 2007, for a package of a legal instrument and non legal measures.

Policy Update

You may recall that in May, the French MEP Bernadette Vergnaud's Report presented a report in the Parliament on the impact and consequences of the exclusion of health services from the Directive on Services in the Internal Market and called for a directive on health services, in parallel with legislation on general interest social services, included in the objective, included in the objective of a framework directive on services of general economic interest.

The Secretariat will keep you informed with future developments.

2. The New European Health Strategy

As informed in previous Internal Mailing issues, the European Commission has committed to adopting a **Health Strategy White Paper** as part of its Legislative Work Programme for 2007. The aim of the new Strategy will be to put in place an overarching, strategic framework with measurable objectives for 2008-2017. The strategy will stress three key principles: (1) to take a value-driven approach, (2) to recognise the links between health and economic prosperity and (3) to integrate health into other policy areas. It should build on current attempts to improve coordination and integration of health protection within the Commission's services, under the leadership of DG SANCO.

The strategy will also put in place a new implementation system of structured cooperation, within which the European Commission will work with Member States to put in place indicators to monitor the progress of the Strategy.

3. Programme for Community Action in the field of Health (2008-2013)

As informed previously, this proposal replaces the initial proposal from 6 April 2005 for a *Community Programme for Health and Consumer Protection*. This came out following the European Parliament's first reading of the 2005 proposal and following the inter-institutional agreement from 17 May 2006 which decided on the budget (€365.6 million, about one third of the amount foreseen in the initial 2005 proposal). The new programme has three main objectives:

- To improve citizens' health security
- To promote health for prosperity and solidarity
- To generate and disseminate health knowledge;

In terms of geographical coverage, the programme is open wider not only to EU Member States, EEA countries and EU accession countries, but also to the European Neighbourhood Policy countries and Western Balkan countries. Several financial mechanisms are foreseen: co-financement for projects, operational costs for non-governmental organisations or network (up to 60%), joint financing for a public body or a NGO by the European Commission and Member States (up to 50%) and joint actions with other Commission's programmes.

The Commission is currently working on establishing a set of selection and award criteria for organisations eligible for financial support from the EC.

4. E-health Inter-operability

The European Commission, DG Information Society is preparing a draft recommendation of e-Health Interoperability. EPF has provided an input from a patient perspective to the draft recommendation, emphasising the need to strongly and explicitly recommend the Member States to give real and equal opportunities to patients' organisations, including potentially marginalised and underrepresented patients, to share their unique and direct experience since the very onset of the policy process, from the design and planning to the monitoring and evaluation stage. EPF has also emphasised that, in the interoperability framework, the information should be transferred with patients' and, when necessary, with carers' consent.

EPF is actively contributing to the eHealth Users' Stakeholders Group, which is an Advisory Group of the i2010 Subgroup on eHealth, to the DG Information Society. The next meeting of the group will take place on 27 September.

5. Animal Testing

EPF has prepared a Statement from EPF's, members and allies on a patient perspective on the use of animals in biomedical research. We believe that properly regulated animal research continues to be essential in many aspects of medical research and a vital, legally required stage in the development of treatments for patients with unmet medical needs. In the Statement, we call for a proportionate, appropriate and transparent regulatory framework, designed with proper consideration of the rationale behind the research. This regulatory framework should prevent abuse, not compromise safety of products that may emerge, and not delay progress towards new therapies. We also advocate accelerated efforts into research into viable alternatives to animal testing.

6. Consultation on the future of pharmaceuticals for human use

The European Commission launched a consultation on 19th July on the <u>future of pharmaceuticals for human use</u>. The Commission intends to improve the regulatory, non-regulatory and RTD framework for pharmaceuticals. Following this public debate, the Commission intends to address a Communication to the Council of the European Union and to the European Parliament on the future of the EU Single Market for Human Use. EPF has prepared a <u>draft response</u> that will be finalised for the deadline of 12th October.

7. Cooperation with other NGOs

As informed previously, EPF is part of a Stakeholder Consultation Group on Information to Patients, which was set up by the European Public Health Alliance (EPHA). The aim of the group is to coordinate action with other health and consumer organizations for a common advocacy strategy to maintain public health concern in the debate on information to patients.

The Group has prepared a Joint Statement on Information to Patients: the Way Forward which is the first step of the advocacy strategy and which reflects the consensus achieved during the first two meetings. The Statement underlines general principles related to consumers' and patients' rights to access quality health information, empowerment of patients and potential users of health services, role of health professionals as a primary source of health information to patients and calls for a comprehensive analysis of existing initiatives, from diverse sources, of providing health information.

The next meeting of the group will be held on 17 September. Roxana Radulescu will represent EPF at the meeting

8. EPF Funders' Briefing Meeting

On 12th September, EPF organised a briefing meeting for funding partners to give an overview of the key achievements over the last year and our plans and aims for 2008 and beyond. We welcomed 10 representatives from industry partners to the meeting, to which the EPF board also participated.

9. EPF / European Standing Committee of Doctors (CPME) joint meeting

On 13th September, the EPF board and director held a creative workshop with the executive committee and Secretary General of CPME. The day resulted in a firm commitment for EPF and CPME to work together more closely, and to agree a set of principles and work plan to take this forward. EPF President, Anders Olauson said of the day "This is, in a way, a historic development – the start of a very exciting cooperation that will bring dividends for both our organisations and our members".

A working group will be set up to develop the set of principles. If any EPF members would be interested in joining this working group, that will also be made up of selected board members from each organisation, please contact the secretariat.

Further details on the outcomes of the meeting will be send to the EPF members in due course. EPF will be exploring similar creative workshops with other health professional stakeholders in 2008.

10. EFPIA Think-Tank meetings

Christoph Thalheim (EMSP) chaired, on behalf of EPF, the EFPIA Special Think-Tank meeting on Funding for Patients' Organisations on 10th September. Roxana Radulescu represented EPF Secretariat at the meeting. A presentation on eligibility criteria for funding for European patient organisations under the EU Public Health Programme was given by Daniel Mann, from the European Commission DG SANCO. EPF representatives highlighted the importance of ensuring that the reference to 'independent of industry'is interpreted to include patient organizations that receive unrestricted funding from industry in accordance to strict independence and transparency rules.

A recent report on Access to funding and diversified resources for European patients' organisations was presented by Marc Dober (APCO), who introduced the general EU funding framework and the foundations funding framework. The report recommends that patients groups should position themselves as a voice of reference and that the outreach to the Commission should start immediately, based on sharing information and expertised with the EC. Also, patients' organisations should seek partnership opportunities and identify the differences and uniqueness of their own projects and also explore a "Round Table of Foundations" to establish a long-term cooperation.

Anders Olauson and Roxana Radulescu attended the afternoon think-tank meeting. The discussion included an update on progress in the High-Level Pharmaceutical Forum on information to patients, relative effectiveness and pricing and reimbursement, an update on the innovative medicines initiative and on the latest developments on animal testing directive, as well as an update on the WHO draft Global Strategy and Action Plan on Public Health, Innovation and Intellectual Property.

11. European Commission Patient Safety Working Group meeting

Roxana Radulescu represented EPF at the meeting of Working Group on Patient Safety of the European Commission, which was held on 12 September, in Brussels. Set up under the High Level Group on Health Services and Medical Care, this Working Group brings together representatives from 27 EU Member States, OECD, WHO, Council of Europe and key stakeholders representing patients (EPF), health professionals (CMPE, PGEU, EFN), and healthcare settings (HOPE). The meeting was an opportunity to explain the Commission's Patient Safety Initiative and the links with the Health services initiative and the Council Recommendation on the prevention and control of healthcare associated infections. The initiative is due for adoption in the second half of 2008, under the French EU Presidency. This will include an overview of the key elements and processes and a draft timetable for action.

12. Round Table on Health Strategies in Europe

Roxana Radulescu attended the EU Portuguese presidency Round Table on "Health Strategies in Europe" on 12-13 July, in Lisbon. The conference brought together representatives of the European Commission, the Council of Europe, the European Parliament and the World Health Organisation, as well as academics and NGOs representatives and addressed questions like:

- What sort of framework can guide the development of a European Health Strategy and ensure coordination with Members States and with other international organisations?
- How can an overarching strategic framework help coordinate specific disease management strategies?
- How can we ensure a proper balance between the operation of the single market and the functioning of national health services systems contributing to European-wide health gains?

Parallel sessions on specific areas looked at the most effective approaches to address specific disease priorities - such as cancer, cardiovascular diseases, diabetes, gender-sensitive strategies, obesity, oral health and tuberculosis. Various patients' groups stressed the importance of having a Patient-centered EU strategy and the need to learn from the experience of patients themselves. Involving effectively NGOs in the implementation was also emphasised.

13. Meeting of the Health-EU Portal Editorial Board

EPF was represented by Roxana Radulescu at the 2nd meeting of the Editorial Board of the Health-EU Portal, which was held in Luxembourg on 28 June. The Editorial Board brings together participants from across EU Member States, NGOs and other parts of the Commission.

The Health-EU Portal started issuing a Newsletter, which is published in 20 European languages and hosts links to interactive features on public health. It aims to keep citizens updated on health-related events and publications, conferences and campaigns, while in each edition a topic would be dedicated to a European or international day of action in the field of health.
