A warm welcome to the September issue of the EPF Newsletter. In this issue we are excited to inform you about a number of key events coming up this autumn.

We are also delighted to give you a flavour of our forthcoming campaign around the European Parliament Elections - "*Patients and Participation = Our Vote for a Healthier Europe*". The campaign will be launched in Brussels on 1 October at a reception hosted by EPF, to which Commissioner Borg will participate. We hope we can count on you for your support!

Our Regional Advocacy Seminar will take place in Zagreb, Croatia, on 28-29 October bringing together leaders from Croatia and EU Candidate Countries. As we go to press, we prepare for the European Health Forum Gastein 2-4 October, where once again we will run a workshop, focussed this year on health, social investment and patient involvement, and will contribute a patient 's perspective to many other sessions.
