A WORD FROM EPF PRESIDENT AND DIRECTOR

A warm welcome to the April issue of the EPF Newsletter.

As we enter the last crucial weeks before the 2014 EU Elections we are delighted to report on the support of key decision-makers that promised to commit to a patients' perspective in their work for the next parliamentary mandate. We also share with you the important testimonial of Katie Murphy, one of the patient/actresses featured in our 2014 campaign video. Katie lives daily with Cystic Fibrosis and was able to offer us some valuable insight into the real need for a stronger patients' voice in Europe.

We were also pleased to see the Clinical Trials Regulation moving from the European level debate towards implementation at member state level. Other crucial dossiers were formally adopted by the European Parliament on Medical Devices and on In Vitro Diagnostics (IVD) Devices. We commend MEP Roth Behrendt's efforts towards ensuring safer devices and more transparency, and we welcome overall the report drafted by MEP Peter Liese (EPP, Austria) but have some concerns regarding provisions on genetic testing.

We took stock of how Greece, Cyprus, Malta and Italy are implementing the EU Directive on Cross-Border Healthcare with patient leaders from these countries at our highly successful second regional conference on this topic that took place on 7-9 April 2014 in Athens, Greece.

Access to healthcare was a core theme at several European Conferences this month and we are pleased to sense a heightened concern about existing barriers and how to overcome them. We represented the patients' perspective at major events such as the Chronic Disease Summit, the DIA EuroMeeting and the WHO consultation on coordinated and integrated care.

Key highlights of the last month also include advances in our Patient-led Academy, EUPATI project, the Joint Action on Patient Safety and Quality of Care (PASQ) and our Capacity Building Programme.

We hope you enjoy reading more on all of this in this Newsletter.
