European Parliament Elections 2019

EPF takes #europeforpatients to the European Parliament \rightarrow

On Wednesday 20 February, the European Patients' Forum took to the European Parliament to present and gain support for our EU elections campaign #europeforpatients. EPF is calling on political leaders of the EU, Parliament candidates and the future Commission, to take action and ensure health is an EU policy priority. "Patients want and expect EU collaboration in health and a strong European health policy," said Nicola Bedlington, Secretary General at EPF.

Policy Update

EPF's take on the opportunities and challenges of electronic medicines information \rightarrow

On 28 November, EPF participated in an HMA/EMA workshop on electronic product information, a follow-up from a July 2018 preparatory meeting hosted at the Spanish Medicines Agency. Following this event, the EMA has launched a public consultation on its "key principles" for electronic product information, with a deadline of 31 July. EPF has been actively contributing to the EMA events, and we will consult our membership on a response to the consultation.

<u>OECD – PaRIS international survey tender is out & new Patient</u> <u>Safety working group looking for patient representatives \rightarrow </u>

EPF has been actively working with the OECD in the last few years, contributing to its work on outcome indicators and in particular, to the shaping of the proposal for PaRIS – the comparative cross-country survey of patient-reported outcomes and patient experiences in

healthcare.

Falsified medicines – new EU rules come into application \rightarrow

The EU falsified medicines directive (FMD) is finally in application, since 9 February 2019 – almost seven years since it was adopted.

Two more steps towards a patient-centred health system in Portugal \rightarrow

The participation of patient and healthcare user organisations in health policy and decision-making was in the spotlight in Portugal this month, with two key events marking the health agenda.

"Patients should be at the centre of healthcare systems in all Member States" says Antonio Tajani, President of the European Parliament \rightarrow

The European Ombudsman's recent inquiry focuses on the level of transparency in the European Medicines Agency's pre-submission activities, and the appropriate extent of the use of "firewalls" in marketing authorisation applications.
