## ANNOUNCEMENT: New Leadership at the European Patients' Forum Secretariat



The European Patients' Forum is delighted to announce the appointment of our new Executive Director, Usman Khan, who will join us from early May. Usman has an established record in European health policy and practice and has significant knowledge of and commitment to patient engagement at all levels.

Usman is currently Executive Director of the European Health Management Association. ## Policy Update

### [Letter to the BMJ Editor on medical implants →](#)

In response to an editorial published in the professional medical journal BMJ at the end of last year, EPF signed a joint letter with several patient and health professional organisations calling for increased transparency and access to incident reports on medical devices. The letter states that “transparency is important for informed decision making for both patients and doctors. For this reason, diminishing transparency to protect commercial secrets and to avoid scaring the public is an untenable argument.”

### [New Roadmap Initiative tackles practical challenges of creating lay summaries of clinical trial results →](#)

EPF was actively engaged in the drafting of the new EU rules, and particularly on the importance of transparency of clinical trial results. Effective communication of scientific research to patients and the public, as we stated in our position paper in 2015, is a vital requirement of an open, inclusive and accountable system. We subsequently took part in a working group headed by the UK Health Research Authority, which developed an EU guideline for the drafting of lay summaries.

### [EPF Continues Work on Vaccination for Patients with Chronic Conditions →](#)

Because of gaps in vaccination uptake among patients, and the important risks patients with chronic conditions face from vaccine-preventable diseases, EPF started an initiative in 2018 on providing information and supporting patient organisations’ advocacy on the importance of vaccination. This year, we are continuing work on this important topic.
