Policy Update

EPF President selected as patient representative to EMA's Management Board →

EPF welcomes the official announcement and confirmation that our President Dr Marco Greco has recently been appointed as one of two civil society representatives to the European Medicines Agency's (EMA) Management Board. This **follows a decision of the Council of the European Union** on 6 June 2019. The appointment is for a three-year term starting on 15 June 2019.

Marco has a long track record of working with the Agency, as a member of the Patient and Consumer Working Party (PCWP), and for six years, serving as a patient representative on the Pharmacovigilance Risk Assessment Committee (PRAC) – a first for the Agency. Read his reaction **here**.

Country-specific recommendations 2019: EPF calls for a strong EU health agenda →

On 5 June 2019, the European Commission published its proposals for Country Specific Recommendations (CSRs) as part of the European Union's yearly European Semester cycle, which monitors the EU Member States' economic and fiscal progress. In a reaction released shortly after this publication, EPF is pleased to note that the Commission's recommendations recognise the need to ensure accessibility and affordability of healthcare for all as part of efforts to enhance health systems' cost-effectiveness and sustainability. Following the success in patient training, EUPATI is now providing education on patient engagement for professionals working in academia and the pharmaceutical industry, to ensure the acceleration of effective patient engagement in Europe.
