AGM 2019: farewell to our Secretary General, Nicola Bedlington and what lies ahead for EPF



On 13-14 April 2019, EPF members gathered in Brussels for EPF's 16th Annual General Meeting. During the event, members of EPF's Board and Secretariat reported on 2018 activities and gave an overview of our current and upcoming work for 2019-2020. The meeting also saw the election of new board members and the approval of four new member organisations.

EPF's Annual General Meeting (AGM) has always played a key role in the democratic and governing process of the organisation. It approves the annual report and the financial report for 2018, and the budget and work plan for 2019. This AGM also saw the election of new Board members and voted to welcome three new members.

It was also our long-standing Secretary General Nicola Bedlington's last AGM after 13 years of leadership. The entire membership and the Board thanked her warmly for being a truly inspirational and dedicated leader and for making EPF the successful organisation it is today: she will be missed. Policy Update

Towards promising opportunities with the new EURIPID collaboration \rightarrow

On 10 April, EPF participated in the first meeting of the Stakeholder Dialogue Platform of the EURIPID collaboration. The EURIPID collaboration is a "voluntary and strictly non-profit cooperation between mostly European countries on building up and maintaining a database with information on national prices of medicinal products in a standardized format." It is funded by the European Commission.

The 4th edition of the European Health Parliament officially comes to a close \rightarrow

The closing session of the European Health Parliament (EHP) took place on 2 April. It officially brought the edition to a close by presenting the recommendations issued by the group of young EHPers. As part of the overall aim to call on European and national decision makers to take action to improve the health of all citizens, they tabled recommendations for the upcoming European Parliament and Commission in the following five areas: data for healthy societies, health literacy, mental health, value of innovation, and air pollution.

project has arrived at the crucial time of having to leverage all the background work done last year into actionable outputs to ensure maximum impact in the ecosystem of patient engagement (PE).

The Brain, Mind and Pain (BMP) initiative has launched its Book of Evidence (BoE) for the 2019-2024 EU mandate. This document sets a strategic vision on policy action to deliver better care for people with neurological and chronic pain disorders in the EU. It will be used as the core policy document of the MEP Interest Group on Brain, Mind & Pain – which will continue after the upcoming EU elections.

On 19 May the European Federation of Crohn's and Ulcerative Colitis Associations (EFCCA) together with its 36 national patient associations and other IBD sister organisations will join efforts to raise awareness of the 10 million people living with IBD worldwide.
