The recent decision of the European Council to drastically cut funds from the EU4Health programme was surprising and regrettable. Despite a lack of clarity on some elements, the new standalone programme proposed by the Commission was a very welcome step towards more resilient health systems in the post-COVID-19 era. However, the Council's decision and the **revised EU4Health budget**, dropped from  $\in$ 9.4 billion to  $\in$ 1.7 billion, goes in the opposite direction: a real step back for health at European level. EPF is working closely with allies and the European Parliament on if and how this might be addressed.

From the Policy and Advocacy team, we present the Summary Report from the virtual launch meeting of our position paper on '**The Value and Pricing of Innovative Medicines.'** We have a lot of news from our Projects team, including the announcement of **CHRODIS PLUS' online conference on 27 October**. Data Saves Lives continues its online campaign while EHDEN has recently announced its collaboration with the European Medicines Agency to address COVID-19.

You will find the second issue of **'Patients in the Spotlight'** by our Communications Officer Emily Bowles in addition to some updates from our Youth Group and the latest initiatives and statements from our Members.

We all still need to play our part and work together to emerge from this crisis stronger and more resolute. Thank you all for working with us.



## "The Value and Pricing of Innovative Medicines" - Summary Report

On 1 July 2020, the European Patients' Forum published and presented its position paper on 'The Value and Pricing of Innovative Medicines.' during an event which took place virtually on 1 July. ## COVID-19 crisis: the time to invest in a healthy future is now.

EPF and several other health organisations expressed their concern and disappointment with the EU Council's recent decision to cut the recently allocated EUR 9.4 billion for the `EU4Health' programme down to 1.8 billion.

The 'EU4Health' health programme was conceived in order to boost the EU's preparedness for future cross-border health threats and to strengthen national health systems in the long-term. In other words: it is supposed to represent the EU's response to the COVID19 pandemic, with people's health and well being lying at the heart of all EU policies. And yet the recent cut suggests a will to drive Europe in the opposite direction, despite the backing of the European Commission and European Parliament. <u>Read our full reaction here>>></u>

# **EPF** responds to WHO European Regional Office's new European Programme of Work

The WHO European Regional Office has published a new <u>European Programme of</u> <u>Work</u> (EPW), titled "United Action for Better Health". This programme aligns with and supports the WHO's 13th General Programme of Work (GPW13). It sets out a vision for how WHO/Europe can better support countries in meeting citizens' expectations on health for the future.

EPF responded to the public consultation on the EPW by submitting a written statement (attached below). We also had an opportunity to give initial comments in an online consultation meeting between the WHO European Office team and non-state actors on 18 June. ## SAVE THE DATE JA CHRODIS PLUS Online Conference on Chronic Diseases 27 October 2020

Over its 3-year lifespan the aim of CHRODIS PLUS Joint Action (2017-2020) has been to support member states in overcoming the burden of chronic diseases by promoting policies and practices that have proved successful in the past. Further refinement and EU cross-border sharing of these tested policies and good practices has been the core idea behind this pan-European project.

CHRODIS PLUS has implemented *21 pilot projects* aimed at testing tools and good practices for certain chronic diseases, and held *17 policy dialogues* (15 national and 2 EU-level ones). It has brought together *over 50 partners* from *21 European countries*.


All good things come to an end: CHRODIS PLUS will hold its **closing online conference on 27 October 2020**.

This conference will illustrate the impact that CHRODIS PLUS has had on public health systems across EU member states over the past 3 years. On 1 July 2020, Data Saves Lives (DSL) held its first deep-dive webinar all about the initiative. The webinar featured a panel of experts from the four DSL working groups, which presented the initiative from their perspective. At the end of the webinar, attendees had the opportunity to ask the panel of speakers questions, which lead to a lively exchange of views. ## **EHDEN to collaborate with EMA to address COVID-19**

On 22 July, the European Health Data and Evidence Network (EHDEN) announced its collaboration with the European Medicines Agency ( $\underline{EMA}$ ) to establish a research framework and network to conduct multi-centre group studies on medicines for COVID-19 patients.

The purpose of EHDEN is to create an international **open science** network in Europe based on common and standardised data models and tools; this will be critical for the development of medicines that real world, observational research can evaluate on effectiveness alongside repurposed medicines. To this end, the EMA-funded project includes **standardised data** sources from across eight European Countries.

The aim of the Forum is to turn patient engagement into reality and the session I attended included three quick-fire presentations on the key topics of Sustainability in Patient Engagement, Patient Engagement Agreements, and work on Patient Engagement in Central and Eastern Europe.

Although these topics may seem diverse, I found a strong theme throughout the session on not only the value of patient engagement, but the importance of recognising that it doesn't need to be a far out or idealised concept, and that there are real, achievable, and tangible steps that can be taken to make patient engagement work for everyone. I was impressed by how well all of the speakers were able to take the complexity of the issue and use their own real world experiences and subsequent data to lay out the different proven ways in which stakeholders - from government organisations, to researchers, to patients organisations - can work together to drive change. Plus, they all also provided useful resources to be used going forward.

The sessions left me really enthused and inspired for the forum and what it is trying to achieve in collaboration with EUPATI, Patient Focused Medicines Development, and the Paradigm Project, with which EPF are also involved. As a result, I've now signed up through their website to attend as many of the further sessions as possible.

## EU leaders agree on €1.82T budget and coronavirus recovery package

EU leaders agreed early Tuesday on a groundbreaking plan to jointly borrow €750 billion to respond to the coronavirus pandemic, which has killed 135,000 people around the bloc and sent economies across the Continent into a tailspin. The EU's recovery fund, to be composed of €390 billion in grants and €360 billion in loans, will be attached to a new €1.074 trillion seven-year budget, the Multiannual Financial Framework (MFF), on which heads of state and government also reached unanimous agreement — bringing the total financial package to €1.82 trillion. <u>Read Full Plan>>></u>

## Pharmaceutical Strategy: Commission launches open public consultation

The European Commission launched an online public consultation on the Pharmaceutical Strategy for Europe. Coming in the wake of the COVID-19 pandemic, the Strategy will aim to ensure Europe's supply of safe and affordable medicines to meet patients' needs and support the European pharmaceutical industry to remain an innovator and world leader. The consultation, launched on 16 June, will last three months. The European Commission published new guidance on what the EU should do to prevent a second wave of coronavirus cases. The document discussed a host of issues, including contact tracing apps, the upcoming flu season and containing localized outbreaks.Commission Vice President Margaritis Schinas and Health Commissioner Stella Kyriakides stressed the need for member states and citizens to remain vigilant.
