It has been a whirlwind month for EPF!

Some good news! The European Parliament and Council agreed on an increased ambitious **EU4Health** budget of 5.1 billion to protect European patients and citizens. EPF also welcomed the outcome of the Plenary Vote on the EU4Health programme which is supportive of many of EPF's proposals. We have engaged in ongoing trialogue negotiations supporting the Parliament's positions on an inclusive governance framework, with direct participation of patient organisations and civil society along with sustainable resources for financial support to NGOs.

The Commission also presented a package of proposals laying out important building blocks for an **EU Health Union**, to enhance European resilience towards future health crises and reinforced mandates for the ECDC and EMA. We consider this as a starting point to build better healthcare for the benefits of all Europeans. The **EU Pharmaceutical Strategy**, another important building block of the EU Health Union, focuses on competitiveness and innovation, access to affordable medicines and tackling shortages. You can view our response below.

Our programme team has been extremely busy, especially with the launch of the latest project in which we are partnering - **PERISCOPE**. We've shared some exciting communication materials for our work with **CHRODIS PLUS**, including a video and leaflet for the Workbox on Employment and Chronic Conditions. Meanwhile, there several webinars and virtual conferences that will be taking place in December, including **EUPATI's Open Classroom**. .

Our Youth Group launched its **Work and Youth Strategy (WAYS) Report** with an interactive webinar launch ending with key recommendations to accommodate the needs of young patients in the workforce. Our members were also really busy with the recent EU developments and their own intiatives, which you can catch up on below.

#### **EPF's Welcomes Europe's new Pharmaceutical Strategy**

EPF welcomes the Commission's new pharmaceutical strategy for Europe, presented earlier this week. In our view, a main strength of the strategy is that it is centred around patients' needs, with accessibility and affordability of medicines at the core.

Our position is based on the premise that health is a fundamental right and a critical investment in society. Medicines are not consumer goods like any others; and patients' lives cannot be measured in purely economic terms. This strategy signals the Commission's understanding that medicines should be considered an essential public good and a core element of health policy.

## **Shaping a European Health Union that Delivers a New Deal for Patients and Civil Society**

The European Patients' Forum (EPF) welcomes the 'EU Health Union' proposal package, presented on Wednesday 11 November by the European Commission.

The project for an impactful EU Health Union should go beyond crisis preparedness and cross-border threats. A true EU Health Union should be built on a broader framework, equipped with the right resources and instruments to address **systemic challenges such as access to quality care, inequalities, healthcare digitalisation and tackle non-communicable and communicable diseases alike**. Civil society organisations should be welcomed as partners in shaping Europe's new health agenda. To enable them to play this role effectively and independently, **co-production** should be built into all EU-level health-related initiatives.

#### **EPF begins the PERISCOPE Project**

PERISCOPE (PAN-EUROPEAN RESPONSE TO THE IMPACTS OF COVID-19 AND FUTURE PANDEMICS AND EPIDEMICS) is a large-scale research project that brings together 32 European institutions and is coordinated by the University of Pavia. PERISCOPE is a Horizon 2020 research project and will investigate the broad socio-economic and behavioral impacts of the COVID-19 pandemic, to make Europe more resilient and prepared for future large-scale risks.

EPF, along with the other partners of the consortium, will carry out theoretical and experimental **research to contribute to a deeper** understanding of the **short- and long-term impacts of the pandemic and the measures adopted to contain it. Such research-intensive activities** will allow the consortium to propose measures to prepare Europe for future pandemics and epidemics in a relatively short timeline.

#### CHRODIS+ Final Conference on Chronic Diseases Making Europeans happier, healthier and more active by implementing good practices

On 27 October 2020, the CHRODIS PLUS project held its <u>closing project conference</u>. Over its 3-years, the aim of the CHRODIS PLUS Joint Action (2017-2020) was to support countries in overcoming the burden of chronic diseases by promoting policies and practices that have proved successful in the previous edition of the project: CHRODIS. Further refinement and EU cross-border sharing of these tested policies and good practices, as well as implementation has been the core idea behind this pan-European project. This Final Conference illustrated the impact that CHRODIS PLUS has had on public health systems across EU member states over the past 3 years. It focused on showing how the good practices, models and tools implemented by the project can be tailored to various

The CHRODIS PLUS Workbox supports EU member states and their workplaces in creating working conditions that foster wellbeing, health, and work ability; prevent the development of chronic diseases; and help individuals with chronic health problems to continue working. The Workbox brings thus benefits for employees, employers, and the entire society.

The CHRODIS Plus Workbox on Employment & Chronic Conditions is composed of 2 tools:

- 1. The Training Tool for Managers promoting inclusiveness of people with chronic diseases at work
- 2. The Toolkit for Workplaces offering 127 means to foster employees' wellbeing



#### **CHRODIS PLUS Multimorbidity Care Model**

Due to an ageing population and improved detection and treatment of diseases, many people now have more than one illness. A patient with multimorbidity presents a unique constellation of needs, disabilities or functional limitations to the health care system. Care for people with multimorbidity is complicated because different conditions and their treatments often interact in complex ways. Despite this, the delivery of care for people with multiple long term conditions is still often built around the individual conditions, rather than the person as a whole. As a result, care is often fragmented and may not consider the combined impact of the conditions and their treatments on a person's quality of life. The **CHRODIS PLUS Integrated Multimorbidity Care Model (IMCM)** aims to overcome many of the issues related to fragmented care. Find out more in this video.

#### **EATRIS+ Patient Advisory Committee kick-off meeting**

On 19 November 2020, the EATRIS-Plus Patient Advisory Committee (PAC) held its kick-off meeting with seven patient representatives from a diverse range of disease areas and European countries. The meeting featured guest presentations from Toni Andreu, Scientific Director of EATRIS; Alain van Gool, Head of the Radboudumc Translational Metabolic Laboratory; and EPF member EATG (European AIDS Treatment Group), who has been brough on board the project to support the coordination of the PAC.

The PAC will inform EATRIS-Plus activities from a patient perspective and will identify mechanisms for meaningful patient involvement and input throughout the project. PAC members will attend key project meetings and will contribute to the development of a patient involvement toolkit for translational researchers, as well as other key deliverables of the project.

EATRIS-Plus will deliver innovative scientific tools to the research community and will reinforce EATRIS' leadership in the European Research Area, particularly in the field of Personalised Medicine research and development. This can have a big impact for patients, as it can reduce trial-and-error treatments, enable better decisions about which medicines may be more effective, and it can help to manage rising healthcare costs.

#### **DHE Consortium Meeting**

On 12-13 November, the DigitalHealthEurope (DHE) consortium held its last annual meeting. Colleagues from 17 collaborating partners dialled in to share the work done so far, and discuss the exciting upcoming activities to foster the digital transformation of health and care, ahead of the project's conclusion in the Summer 2021.

The European Patients' Forum participated in the meeting and focused in particular on the key learnings of its <u>5-6 October Multi-Stakeholder Workshop</u> on Digital Tools for Patient Empowerment and Person-Centred Care. EPF shared how the insights gleaned during this two-day event will shape our main output in DHE: the White Paper on boosting active cooperation between patients & health and care providers, and our communications activities in the final months of the project. Another pivot point was the further collaboration and exchange among partners and conducting detailed plans on how this can be achieved. DHE strongly depends on cross-cutting activities within the project.

DHE is a Horizon 2020 initiative that aims to provide comprehensive, centralised support to the digital transformation of health and care priorities of the Digital Single Market.

#### **European Health Data Space virtual conferences**

On 10 November 2020, the Data Saves Lives (DSL) initiative participated in the <u>virtual conference</u> Health Innovation – the European Health Data Space and Real-World Evidence, co-hosted by the RWE4Decisions and German Presidency of the Council of the EU.

DSL hosted a digital booth, focusing on the importance of health data, understanding how it's used, establishing a trusted environment for dialogue, and key recommendations for responsible use and good practice. Robert Greene, Advisory Board Member of DSL also participated in the virtual roundtable on using cancer as a case study for the use of real-world evidence. During his interventions, Robert highlighted the need to involve both citizens and patients in conversations about health data — 'in our lifetime, we will all be confronted in one way or another with cancer' he said; by involving all citizens in health data discussions, we can have a broader conversation. The

## Recap of the Webinar Launch of Work and Youth Strategy (WAYS) Report

The EPF Youth Group's Work and Youth Strategy (WAYS) report findings officially launched on the 18<sup>th</sup> of November. The results and findings of the report were presented in the webinar, alongside real testimonials of patients in the workforce. The idea was initiated back in 2016, where the Youth Group identified that emotional and physical symptoms of chronic conditions, along with the stigma associated with chronic conditions caused a real struggle for young patients searching the job market. The initial aim was to present evidence from patient's real experiences and find solutions to the problems and limitations that surfaced, both general and tailored to each unique condition.

To achieve this, an online survey was published in December 2018, that had 62 respondents across 21 EU countries. A high 35% of participants admitted that they would not disclose any 'invisible' condition under any circumstances, supporting further the 44% of respondents who admitted to the challenge of finding a job. Some of the WAYS key findings that were highlighted during the webinar included the long-term effects of missing out on education due to a chronic condition, as well as the negativity and stigma associated with the abilities of young patients, creating fear of discrimination among them.

Throughout the report, we recommend flexible working policies, such as adjustable hours and working remotely, to accommodate the needs of young patients, as well as training



revealed the struggles young patients often endure, with a personal touch from each speaker and unique ways of how they have resolved problems that came their way. The Youth Group strives to make its findings more accessible, and we made sure that the human right to be integrated into the society as an equal was a core principle that was highlighted throughout our report and webinar.

#### **BioNTech/Pfizer and Commission reach vaccine deal**

BioNTech and Pfizer confirmed that they completed a deal for the European Commission to purchase up to 300 million doses of their front-runner coronavirus vaccine. The Commission agreed to purchase 200 million doses of the vaccine, with the option to purchase an additional 100 million and will be manufactured in both Pfizer's Belgian and BioNTech's German production sites. The company hopes to manufacture 1.3 billion doses in 2021. The companies announced their vaccine was found to be 90 percent effective earlier in the month.

#### Moderna says its coronavirus vax is more than 90 percent effective

U.S. biotech company Moderna announced that its coronavirus vaccine is more than 90 percent effective, according to preliminary results from a late-stage U.S. trial involving more than 30,000 people.

The results are on par with those announced by BioNTech and Pfizer, which reported that their coronavirus vaccine is more than 90 percent effective. Both Moderna and BioNTech/Pfizer employ mRNA technology for their jab. The EU hasn't signed a deal with the American company yet.

#### AstraZeneca, Oxford: Coronavirus vaccine is 70 percent effective

A coronavirus vaccine from Oxford University and AstraZeneca is 70 percent effective, according to interim analysis from a large scale clinical trial. The announcement Monday combines data from two different dosing regimens. When the vaccine was given as a half dose and then a full dose, it had an efficacy of 90 percent. When given as two full doses, it showed 62 percent efficacy.
