Our Policy team sent proposals to the co-legislators on **EU4Health Programme** requesting greater patient involvement and an enhancement of coordination amongst member states. They participated at the **European Health Forum Gastein** and several other conferences and launched two surveys, including one on **Artificial Intelligence**, with the deadline ending on 31 October.

October was also an extremely busy month for our project team. EPF was able to present materials on the CHRODIS recommendations and quality criteria (QCR), and a workbox on employment at the **CHRODIS+ Closing Conference**. Our **Digital Health Europe Workshop** was a great success bringing together key stakeholders with an interest in digital tools that can empower patients and foster their collaboration with healthcare professionals. We also took part in the kick-off meeting for our newest project, **H20**, which focuses on Value Based Healthcare. Another major milestone was the launch of the **PARADIGM Patient Engagement Toolbox**. More information on this below.

EPF's proposals to co-legislators on EU4Health

The COVID-19 crisis has highlighted, once again, that patients should be involved in shaping health policy at national and European levels, and why their unique knowledge and expertise, collectively and individually, are vital. We believe that the EU4Health programme represents a unique opportunity to act on this, whilst enhancing European coordination to protect our health.

In the context of ongoing discussions within the Council and European Parliament on the EU4Health programme proposal, EPF has continued to advocate and stress [our proposals for the Programme](#). On 9 October, EPF sent a **letter** to the Heads and Health Attachés of the Permanent Representations to the EU, highlighting concerns with some elements of the Council's compromise text. On 12 October, we shared **voting recommendations** with Members of the European Parliament's Committee on Environment, Public Health and Food prior to their vote on the Parliament's position.

EPF welcomes the results of the Parliament's Health Committee vote as an important improvement to the Commission's proposal for the Health Programme. In the context of Member States' position on the programme, EPF is concerned that the direction [Council discussions](#) are taking may jeopardise the originally strong proposal from the Commission and further progress brought by the Parliament. In the coming weeks, we intend to further support the European Parliament's work in view of the Parliament Plenary vote, taking place on 12 November. We intend to also engage, together with our members and other civil society organisations, in forthcoming negotiations between the co-legislators, advocating for an ambitious, well-resourced and patient-centred EU4Health Programme.




EPF Survey on Artificial Intelligence in Healthcare

Artificial Intelligence (AI), together with big data, has the potential to transform care delivery, and change several aspects of the healthcare value chain: population health, healthcare operations and healthcare-related innovation.

Given this rapid increase of interest in the importance of AI in healthcare and in view of upcoming policy activities, EPF has decided to reinforce its engagement on this matter to ensure that the patients' views will be adequately represented in the future discussion and EU-level debates, starting with this first EPF survey on AI.

The survey report will be published and available for free on EPF website in the coming months. **The survey deadline has been extended to 31 October 2020.**




Young patients and employment: Barriers and good practices - Launch of the EPF Youth Group WAYS survey results 18 November (18:30 - 19:15)

EHC Virtual Conference 2020

From 5 October through 9 October, I followed a virtual conference hosted by European Haemophilia Consortium. This year's most important event for people with bleeding disorders brought a variety of speakers from all around wider Europe to discuss novelties. After a warm welcome from Amanda Bok, CEO of EHC, and Declan Noone, President of EHC, all the speakers were given a platform to present their work and also to be a part of panel discussions along with patients.

First session was Talking Pain, since pain is and will be present in our lives and we could understand how important it is that we address pain properly. Although for many years the Von Willebrand Disease was not in focus, things are starting to change as it was the topic for the rest of the first day. The second day taught us the importance of individualized treatment. Women with bleeding disorders was the key topic for day three. Novel therapies such as bypassing agents and gene therapy alongside with safety assessments were reserved for the last two days.

Throughout these 5 days I was able to acquire lots of valuable information, find answers to some incredibly difficult questions and stay up to date with current health crisis. For me personally, it was incredible and encouraging to be a part of an event with all of these wonderful and motivated people, As a patient with chronic illness it gives me a sense of security knowing that we are not alone.

Council affirms countries' health competence in EU4Health stance

EU council are sticking with plans for a limited €1.7 billion budget for the new EU4Health program. In a newly agreed position, EU ambassadors said they will finance the program with €1.7 billion from the seven-year Multiannual Financial Framework (MFF), in 2018 prices (worth €1.9 billion in current prices). The Commission originally proposed spending €9.4 billion on the program, but a €7.7 billion contribution from the EU recovery fund was cut under a budget deal between EU leaders in July. The Council's position did stress strengthening the EU's role in global health, especially with reforming the World Health Organization. The program is due to start January 1, so needs to move to trilogue negotiations quickly. The Parliament's position still needs sign off in plenary, which is expected in November.

Sanofi, GSK to allocate 200M coronavirus vax doses to COVAX

Drugmakers Sanofi and GSK announced a plan to make 200 million doses of their coronavirus vaccine available for COVAX, the global effort to ensure equitable access to coronavirus vaccines. The COVAX facility aims to distribute two billion doses by the end of 2021. Ninety-two higher-income countries have signed up to the facility as "self-financing" members, meaning that they'll pay for the vaccines themselves, while another 92 low and middle-income countries will be supported by the facility.

Commission to buy rapid-result coronavirus tests

The EU is buying €100 million worth of rapid-result test kits to help cope with rising coronavirus infection numbers. The tests will be purchased through the emergency support instrument and then be distributed to member countries. The Commission has issued coordinated testing recommendations to help member countries align their strategies and create a framework for mutual recognition of test results throughout the bloc.
