We want to wish Desislava Ekzarova, our departing Membership and Governance Officer, the best of luck on her future endeavours.




Welcome Aboard to Martina Continisio

Our Policy Activities in September

Over the past month, EPF continued to work in collaboration with several other EPF members and public health civil society organisations, to further campaign on the topic of operating grants within the **EU4Health Programme**. Following our meeting with Health Commissioner Stella Kyriakides, we attended a workshop organised by the European Commission on 10 September. Commission officials present at the meeting confirmed the reception of input provided by civil society organisations in a preceding targeted consultation, including the reception of numerous concerns on the re-establishment of operating grants.

We continue following the developments around the new European Health Emergency Preparedness and Response Authority (HERA). The HERA will be a new EU agency for strengthening the European Health Union with the aim of better preparedness and response to serious cross-border health threats by enabling rapid availability, access and distribution of needed countermeasures. Together with the European Public Health Alliance (EPHA), we published a joint statement asking the European Commission to ensure that the new HERA will serve patients' needs.

On cross-border healthcare, we spoke in a virtual workshop organised by the European Commission in which a new series of Guiding Principles for the prior authorisation of crossborder healthcare was discussed. This workshop took place in the context of the ongoing European Commission study to enhance the implementation of the Cross-Border Healthcare Directive 2011/24/EU to ensure patient rights in the EU. During our intervention, we presented the patients' perspectives on cross-border healthcare. I.e., patients' rationale for seeking care abroad is based on "need" as much as "choice". In addition, we commented on the provided draft Guiding Principles, explaining how we think National Contact Points' websites can and should be improved, providing better and more tailored information to patients.

The European Commission invited us to attend a call together with the European **Consumer Organisation** (BEUC) to discuss the ongoing situation about the replacing of Directive 98/79/EC on In Vitro Diagnostic medical devices (IVDs) with a new Regulation (2017/746). The application date for this file is 26 May 2022, but there are concerns about the feasibility of the timetable. During the meeting, EPF intervened to say that said that the best solution is the one that addresses patients' needs, minimising the risk of having shortages of IVD devices in the market or making it more difficult for patients to access them. EPF would not be against delaying the implementation of the Regulation if that is necessary to avoid access problems.

updating the **EPF AI Knowledge Hub**. Furthermore, the AI **Webinar series**, following its kick-off on 8th July, continued last 29 September with a webinar on AI in Healthcare: Ethics and Implications (more info **here**).

Finally, The VAC-PACT tender has now entered its final stage, with the final deliverables (the Advanced Toolkit and a Final Report with policy recommendations) having been submitted on 31 August. We will now wait for the Commission's approval or further comments on the submission. The Toolkit will be available in 24 EU languages.



On 28 September 2021, the **EHDEN** (**European Health Data & Evidence Network**) launched its first course for non-experts as part of its EHDEN Academy course offering. This series of three introductory modules was designed by the European Patients Forum and EHDEN colleagues.

This free introductory course is designed to familiarise non-experts with the **basics of health data** in terms of how it's created, shared and analysed. It uses a real-life example to illustrate how EHDEN is collaborating with research partners to **maximise the value of health data** to ultimately **improve patient treatment and outcomes.**

This first course will cover key foundational concepts such as: real world data, real world evidence, real world use cases.



EU extends vaccine export controls

The European Commission extended the EU's vaccine export authorization program, which permits it to monitor and control shipments of coronavirus vaccines outside the bloc. The EU set up its authorization mechanism in January after AstraZeneca underdelivered on its contract with the bloc. The Commission already extended the mechanism for an extra three months until September, and is now extending it for another three months until the end of the year.

Commission starts funding cancer research 'mission'

The European Commission kicked off a major research effort to tackle cancer, promising €378 million until 2023 for its cancer mission. The mission sets out to "improve" the lives of more than 3 billion people by 2030 "through better prevention, cure and quality of life."

Commission opens public consultation into pharma legislation overhaul

The EU Commission wants to hear from citizens and interested parties regarding gaps in the bloc's medicines regulation. The EU plans to overhaul pharmaceutical legislation to tackle some of the most pressing issues in pharmaceuticals — many of which have been laid bare by the coronavirus pandemic. These include drug-supply issues, the need for medical treatments where none exist, and the dwindling efficacy of antibiotics. Feedback on plans to update the EU's pharmaceutical legislation, which has not been changed in 20 years, begins with a questionnaire seeking views from across the sector.

EU countries have donated 10 percent of coronavirus vaccine doses pledged by year-end

EU countries have so far donated roughly 28 million COVID-19 vaccine doses to low- and middle-income countries. The donations make up 10 percent of the more than 266 million doses EU countries pledged by the end of 2021. Of those pledged, more than two-thirds will go to COVAX. Another 10 percent will go directly to countries, 6 percent is via the EU's Civil Protection Mechanism, and another 5 percent is still to be determined.
