### **January Highlights from Team Policy**

The new year has not interrupted the continuity of our work on the review of the EU pharmaceutical legislation. In January, we continued to work with the Members of the European Parliament (MEPs) engaged in the review and to convey the patient perspective as part of the negotiations. We also discussed the pharmaceutical legislation, and more specifically shortages, at a meeting on January 11 with a key Member State institution, the French Senate, which is developing its position on the legislation. On the topic of shortages, we finalised a consultation of our member patient organisations to gather examples and experiences, which helped inform **our statement** and will feed into our advocacy in the coming months. Back in the European Parliament, on January 31, our Executive Director Anca Toma will present our views on the review of the pharmaceutical legislation at the EU pharmaceutical roundtable organised by MEP Adam Jarubas.

Beyond the pharmaceutical legislation, our Policy Officer Julie Spony travelled to Paris to participate in the OECD High-Level Policy Forum on the Future of People-Centred Health Innovation to represent the Patient Advisory Panel of the **OECD's Patient-Reported Indicator Surveys** (PaRIS). PaRIS is an initiative to develop a new generation of indicators for patients with chronic diseases. We also answered two public consultations at EU level, one on the review of the Health Emergency Response and Preparedness Authority (HERA), the European Commission service set up two years ago in the wake of the COVID-19 pandemic to improve EU preparedness and response to future pandemics, and one on the **EU4Health programme**, where we highlighted the essential role of sustainable funding for patient organisations.

On the digital health front, our Policy Officer Milana Trucl gave a lecture on artificial intelligence to students enrolled in the **Master in International Patient Advocacy Management**, as part of EPF's partnership with Cattolica University (Italy). With regards to European Health Data Space (EHDS), we continue to follow closely the interinstitutional negotiations which started in December 2023. Moreover, our policy team also provided input to a report by the European Institute of Innovation and Technology on the feasibility of implementation of EHDS, which will be published later this year. In January our focus shifted to preparations in close collaboration with the Capacity and Membership team, of the event on artificial intelligence that will take place at the EPF Annual General Meeting.

### Interim Evaluation | The EU4Health Programme 2021-2027

The EU4Health programme is a unique opportunity to make a significant contribution to the post-COVID-19 recovery and build stronger, more resilient, and patient centred health systems. It has the potential to boost cooperation in health and pave the way for a true European Health Union that provides real added value to all patients.

Since 2021, EU4Health Work Programmes have enabled meaningful progress in areas where there is EU added value such as digitalisation, the fight against chronic diseases, and strengthening of the EU's preparedness and response capabilities. Moving forward, we support continued efforts in these areas as well as increased emphasis on health literacy and patient information, which are essential in the fight against many cross-border health threats and in achieving sustainable, well-functioning healthcare systems.

Most importantly, one area where the Programme needs considerable strengthening is support and sustainable funding to patient organisations and other health-focused civil society organisations (CSOs) to allow them to fulfil their core public health mission.

### Julie Spony at the OECD High-Level Policy Forum on The Future of People-Centred Health

Julie Spony, our Policy Officer, represented EPF at the **OECD-OCDE** High-Level Policy Forum on The Future of People-Centred Health, held in Paris.

During the event, panelists addressed the Patient-Reported Indicator Surveys (PaRIS), the first international survey assessing patients' experiences of primary care in 20 countries around the world.

As the voice of patients in Europe, the **E**PF is part of the PaRIS Patient Advisory Panel, working to integrate essential patient needs into the broader initiative for establishing patient-focused healthcare systems.

## Survey: Join PROPHET in their goal to improve personalised prevention

In the European Union, more than 900,000 individuals die prematurely each year due to preventable disease risk factors. Transitioning from conventional disease treatment methods to a "person-centred" emphasis on prevention and early diagnosis could curb this trend.

Although prevention is nowadays a high priority at EU level, personalised preventive strategies are not as widely used as other personalised medicine approaches. To address this gap, we invite you to participate in a survey designed by **PROPHET** on the perceived barriers, challenges, and enablers for the adoption of personalised prevention strategies in the EU and beyond.

The survey was developed by researchers of the **National Institute of Health Doutor Ricardo Jorge** (INSA), in collaboration with the **Università Cattolica del Sacro Cuore** (UCSC), and the **Karolinska Institute** (KI), and based on the literature and on interviews with experts in the area of personalised medicine.

Funded by the European Commission under the Horizon EUROPE Programme, **PROPHET** aims to support the definition and implementation of innovative, sustainable and highquality personalised strategies that effectively tackle chronic diseases.

Part of the **Athens Digital Health Week**, this event provided a great opportunity to showcase the platform, test its usability and contribute to its improvement.

Participants were asked to solve the following challenges:

- Identify rules to personalise patient information.
- Design aligned medicine information visualisations for patients.

The different teams tapped into their skills to propose innovative solutions and improve the existing features of the application.

### **EATG** launches "What We Wanted was What We Needed" a documentary on the Sitges Meetings

On January 25 EATG launched "*What We Wanted was What We Needed – Rebuilding a Community of Memories and Inclusive Advocacy*", a feature documentary on the Sitges Meetings. This film documents stories, experiences, results, and lessons learned from the Sitges meetings. This documentary happened within the framework of the **Belong project**, advocating for the inclusion of people living with HIV in non-HIV clinical trials.

The Sitges Meetings were a series of community-owned multi-stakeholder meetings, held between 2007 and 2017 in Sitges, Spain and organised by the EATG. The purpose was to promote the inclusion of people with HIV/hepatitis C (HCV) coinfection in clinical trials for emerging hepatitis treatments, and rapid access to new, safe and effective treatments.

The documentary premiered online on on 25 January 2024 at 20.00 CET. It will be available for free online streaming for one month.

### New Campaign | European Alliance for Cardiovascular Health

The European Alliance for Cardiovascular Health has launched its campaign to promote cardiovascular health in the EU and fight against CVD.

CVD cost the EU an estimated €282 billion in 2021, topping the leaderboard as the cause of more than one-third of all deaths and impacting the lives of some 60 million people. Misperceptions plague CVD: it is often still regarded as a "man's disease" although women are more than twice as likely to die after a heart attack than men. Cardiovascular conditions also affect children and young adults. In Strasbourg, EACH unveiled the "Vote Cardiovascular Health 2024" exhibition, hosted by MEP Elżbieta Łukacijewska (Poland) and MEP Radka Maxová (Czech Republic), long-standing supporters of cardiovascular health. The exhibition highlighted CVD's toll on the EU, country by country, while the online media campaign is calling on leaders to #VoteHealth2024.

"Vote Cardiovascular Health 2024" is a unique initiative that zooms in on the critical issue of cardiovascular health, the leading cause of mortality in the EU and worldwide.
