

Patient involvement in medical professionals' education A survey for patients and patient organisations About this survey

What is the survey about?

Through this survey we hope to gain a better understanding of how common it is for patients (individual patients or patient organisations) to participate in continuing professional development / continuing medical education (CPD/CME) activities, what kind of activities they participate in, and what their experiences are like, as well as get patients' recommendations on how to improve this.

Who is the survey for?

The survey is meant for individual patients, patient advocates and experts, family members, informal caregivers, or representatives of patient organisations.

Do I need to know about CPD/CME to answer the survey?

You do not need in-depth knowledge on the topic to complete this survey. Even if you or your patient organisation has never participated in CPD/CME activities, you can still give your opinion about some aspects of it.

How much time will it take?

This survey consists of a mix of open and multiple-choice questions. It should take around 15-20 minutes to complete. Parts 3 and 4 are optional. Please do try to answer all the questions if you can; in our analysis we can only take into consideration completed surveys in order to have reliable and comparable results.

Can I see the questionnaire before answering?

To prepare your answers in advance or to consult with colleagues, you can take a look at the questionnaire in pdf format **here**.

What is the deadline for completing the survey?

The survey is open until 15 January 2021.

How will you protect my data and privacy?

You are under no obligation to participate in this survey. If you choose to do so, your replies will remain anonymous. EPF is managing the survey, and we will treat the results as strictly confidential. We only ask for information that is needed to analyse the results, for example "demographic", country and disease-area information. This will also remain anonymous. No personal information will be published.

By completing and submitting this survey you are providing your informed consent.

How will the survey responses be used?

We will use the survey results to identify gaps and need for further actions as well as planning specific activities towards increasing patient involvement in CPD/CME.

We will publish a summary report of the survey results, which will be freely available on EPF's website. The report will include information in a non-identifiable form.

We may wish to conduct personal interviews at a later stage to gain more information. For this we will always ask for permission separately. Completing this survey does not oblige you in any way to participate in further activities.

Patient involvement in medical professionals' education A survey for patients and patient organisations Background - why we are doing this survey now

One important factor in ensuring the high quality of healthcare is that healthcare professionals have the right skills, knowledge and attitudes to practice person-centred care – including shared decision-making, listening, supportive and effective communication, empathy and partnership.[1] Across Europe, the health workforce is in transition and countries will need to plan for new skills and roles, such as coaching and advocacy, to be able to better address the needs of patients with chronic conditions.[2]

Patient organisations' role in shaping the basic and continuing education of professionals has until now been unrecognised and under-used. EPF calls for embedding patient involvement in all professional education.

Patients can be involved in professional education in many ways. At the most basic level, patients' stories are increasingly used as learning material. Sometimes role play is used or patients are invited to speak of their experiences in person. However, advanced roles such as having patients as "co-teachers" or having them involved in shaping teaching curricula are still rare.

What are CPD and CME?

CPD

The educative means of updating, developing and enhancing how physicians apply the knowledge, skills and attitudes required in their working lives.

CME

The educational activities which serve to maintain, develop or increase the knowledge, skills and professional performance and relationships that a physician uses to provide services for patients, the public, or the profession

EPF started a collaboration with BioMed Alliance in 2019 on promoting high-quality continuing professional education (CPD), of which patient involvement forms one important element.[3] Continuing professional development, sometimes called continuing medical education (CME), is an important area of education to keep the skills of already practising physicians up to date.

Both CPD and CME aim to keep doctors' medical practice up to date. It is the ethical duty and professional requirement of a physician to constantly update their knowledge and undertake training in areas such as knowledge, skills, safety and quality, communication and teamwork, for example. Competencies go beyond purely medical knowledge and include other areas such as ethics, social and personal skills. Practising professionals need to gain a certain number of "credits" each year to fulfil this requirement.

CPD is the broader concept, while CME is geared towards information and knowledge that is essential to medical practice. CPD/CME can take different forms; one very common form is that professionals attend certain sessions at medical conferences for which they get credits for CPD/CME. Sometimes professionals also do courses online or attend lectures, read articles, participate in live teaching courses or workshops to get credits. Exact requirements vary in the EU.[4]

Medical societies have recently expressed concerns about industry involvement in medical education. Although there are legitimate and valuable areas of co-operation in education between the medical profession and the industry, in their view medical education should be provided by not-for-profit medical societies to guard against bias. Medical education is differentiated from product training.

In Europe, educational activities organized directly by industry are not accredited. The European Accreditation Council for Continuing Medical Education (EACCME) requires that "all funding from sponsors must be provided as an unrestricted educational grant, free of any attempt to influence the programme, individual sessions, subjects for discussion, content or choice of faculty members."
