Job description

Job title: "Data Saves Lives" Coordinator (100%)

Reports to: Senior Programme Manager

Purpose of the role

Research into chronic conditions and diseases, and their management and treatment is increasingly reliant on data generated by patients, physicians and other healthcare workers, hospitals and similar institutions, and many others.

Despite considerable advances in technologies to facilitate and support health-related research, it remains very challenging to be able to use health data, due to concerns of the public, and privacy, security and confidentiality issues.

To meet this challenge, the European Patients Forum (EPF) and allied organisations propose to develop an online portal on health data, to improve awareness and knowledge, promote the importance of data in health research to the public, and to create a trusted environment for dialogue about the use of health data.

The "Data Saves Lives" Coordinator is responsible for the management of this new "Data Saves Lives" multi-stakeholder initiative, for which EPF hosts the Secretariat. Managing the Data Saves Lives Secretariat

- Coordinating the editorial board responsible for reviewing content
- Together with the Core Group, developing and implementing a marketing strategy for the web platform
- Preparing the launch of the web platform in late spring 2019, and co-ordinating the ongoing publicity of it after launch
- Organising regular 'data community' meetings
- Liaising with patient and public representative organisations across Europe, to support their use of the platform, responding to enquiries and communicating with EPF and i~HD contact points about any issues raised by them
- Supporting the launch of the "Data Saves Lives" campaign during 2019, its implementation and follow through into 2020
- With the core group, developing and implementing an evaluation strategy for the initiative
- Overseeing and monitoring the "Data Saves Lives" budget in accordance with EPF procedures

Content and platform coordination

- In collaboration with i~HD, our content and knowledge partner, coordinating and uploading content on the web-platform on an on-going basis
- In cooperation with our service provider, maintaining the web-platform, reviewing the timeliness of updates, accuracy of content uploads and periodically reviewing its overall content and impact, to advise on additional areas of content that may be needed

DATA SAVES LIVES INITIATIVE

APPROVED CONCEPT NOTE

1. Context for this document

Stakeholder meetings in April and June confirmed support for the setup of a European Health Data Platform to raise awareness and provide information about the use of health data in order to establish trust and improve acceptance. Subsequent discussions have confirmed that industry taking the lead in funding the initiative at the start is a pragmatic way forward, but it is essential that a more balanced public-private funding model be established in the medium-term (i.e.: within 2-3 years). As a result, the structure proposed here is intended to guide the Platform through its launch phase of perhaps 18 months – 2 years, after which further adaptation to governance and other elements of this paper will be needed.

As previously discussed with stakeholders, it is intended that the Platform should generate materials which support the members' shared objectives, but that there should also be a strong element of profiling best practice by others and engaging in collaboration with likeminded organisations. Above all, we aim for engagement at member state level and it is also our ambition to reach a wider public with a Europe-wide communications campaign as the project evolves.

It is proposed that EFPIA would be the main source of funding for the Platform over the first 2 years of its operation. EFPIA will seek funding for:

- Staffing of the secretariat
- Preparatory work on strategy development and governance
- Content creation
- Social media strategy
- Meetings and conferences

2. Vision, Purpose, Objectives & Deliverables

VISION

Our vision is a Europe where informed data sharing supports health and scientific research to meet the needs of patients and address the challenges faced by our healthcare systems.

PURPOSE

Our mission is to create a European Health Data Platform that will build awareness and understanding of how data is used and provide a trusted environment for dialogue about the use of health data in Europe.



OBJECTIVES

- Promote wider public understanding and trust in how data is accessed and used responsibly and its value in supporting modern healthcare;
- Empower patients and healthcare professionals to realize the potential of new sources of data and new ways of generating them using digital technologies;
- Create resources that can be adapted for use at national/local level;
- Enable engagement with regulators, payers and other relevant stakeholders.

DELIVERABLES

- Common principles and recommendations on responsible use of health data;
- A repository of resources to empower patients and citizens to understand the data journey and engage in dialogue on the use of health data;
- A patient-led platform, engaging a wide network of stakeholders in dialogue and exchange of ideas;
- Communications campaign on the value of data sharing.

3. Governance

For this initiative to be trusted, credible and effective, it is essential to have a clear and transparent governance structure.

General principles

The Health Data Platform operates on principles of multi-stakeholder governance and is open to organisations committed to improving the understanding of health data and to engage in dialogue on health data related issues, including, but not limited to:

- Patient groups;
- Public Sector Researchers;
- Health Data Networks;
- Life Sciences companies.


A Core Group will be established to drive the initiative. The group will comprise of representatives of the constituencies listed above. Organisations volunteering for the Group would be asked to commit to the time needed to make the projecta success. A Chair will be elected at the first meeting for a two-year period and decisions will be made by consensus. Platform "partners" not participating on the Core Group will comment on the work produced by the platform and the decisions of the Core Group.



In addition to a secretariat, we believe the credibility of the platform would be advanced by two further governance elements:

- A senior advisory group, who would comment on the overall strategy.
 Membership would be drawn from European Institutions, ethics experts, and senior figures from the research community;
- An editorial group that will review all resources developed by the Platform. The
 editorial group will be composed of five representatives including a patient
 representative, a health data expert, a health writer, an ethicist and an expert in
 plain language. The Editorial Group will be an independent body that will ensure
 that all material produced for the Web Platform meets the highest standards in
 terms of quality information.

Overall, the proposed structure looks as follows:



ANNEX: RESPONSIBILITIES

Responsibilities of the Core Group

- Ensure the Platform's has appropriate operational autonomy relative to its funding sources;
- Oversee development of the strategy;
- Agree any necessary rules governing participation in the Health Data Platform;
- Plan an annual meeting of the health data community and call additional meetings should the need arise;
- Develop a financial sustainability strategy, including transition to a publicprivate model;
- Agree on the need for and terms of reference of the Advisory Group and the



Editorial Group;

- Agree procedures for member consultation;
- Oversee the operational proposals of the Secretariat;
- Agree on any collaborations with third parties;

SECRETARIAT

EPF will act as the secretariat for the Platform. The secretariat's responsibilities include:

- Development of draft content and dissemination plan for approval by the Core Group;
- Propose composition of the editorial group to the Core Group for decision;
- Prepare of the Core Group meetings and Editorial Group meetings and Health Data Community meetings;
- Develop and oversee the Campaign;
- Prepare interactions with the Advisory Group;
- Oversee budget and management of expenditure;
- Oversee KPIs and project milestones;
- Propose staffing plan and make necessary recruitments;
- Oversee third party contractors' negotiations.
